

Based on the article 175 paragraph 1 of the Energy law (Official gazette of MNE, 05/16, 51/17,82/20,29/22, 152/22), and article 82 of the Rules for functioning of the Closed distribution system of Luštica Bay, the Luštica Bay Electricity Company Tivat, (hereinafter "LBEC"), issues:

on issuing the consent for connection**

The company LBEC issues the consent for connection of the Unit to the Luštica bay Closed distribution system, which initial owner is the company LUŠTICA DEVELOPMENT A.D. TIVAT, with the seat in Tivat, Novo Naselje, Radovići 85323, Tivat Municipality, registered in the Central Registry of Business Entities in Podgorica under the registration number 4-0008824, tax number 02744597 ("Customer"), with the following technical data:

Notwithstanding the above, the Unit will be connected to the Lustica Bay Closed Distribution System, provided that the Initial Owner:

- i. no later than 7 (seven) calendar days from the day of issuing of this Decision, pays the fee for connection to the Closed Distribution System to the account of the company LBEC, in accordance with the Decision on determining prices and other fees for connection and use of the Closed Distribution System Luštica Bay, issued by LBEC, on 28.02.2020;
- ii. no later than 7 (seven) calendar days from the day of issuing of this Decision, conclude the Agreement on connection and use of the Closed Distribution System Luštica Bay with the company LBEC.

This Decision applies to the Unit and is applicable to any subsequent holder of ownership right to the Unit. In the event of a change of the holder of ownership right to the Unit, the new holder of ownership right to the Unit will be obliged to conclude an Agreement on connection to the Luštica Bay Closed Electric Power Distribution System and conditions of its use with LBEC, no later than 30 (thirty) calendar days from the date of acquisition of ownership on the Unit, otherwise LBEC

Ovo Rješenje se odnosi na Jedinicu i primenljivo je na svakog narednog titulara prava svojine na Jedinici. U slučaju promjene titulara prava svojine na Jedinici, novi titular prava svojine na Jedinici će biti u obavezi da zaključi Ugovor o priključenju i korišćenju Zatvorenog distributivnog Sistema Luštica Bay sa kompanijom LBEC, najkasnije u roku od 30 (trideset) kalendarskih dana od dana sticanja prava svojine na Jedinici, u

### **Explanation**

On the basis of the Long-term Lease and Construction Agreement of 23 October 2009, concluded between the Government of Montenegro, Municipality and Company Luštica Development, the Company Luštica Development was awarded an exclusive right, whether directly or through an affiliated company, to distribute and sell Electricity services to the customers, such as electricity, within the Luštica Bay Project.

For the purposes of distribution and sale of Electricity services to the customers of a closed electricity distribution system of Luštica Bay, Luštica Development established its affiliated company Luštica Bay Electricitycompany doo Tivat („LBEC“);

On the basis of the Energy Infrastructure Lease Agreement, of 28 January 2019, concluded between the company LBEC and the company Luštica Development, the company LBEC was awarded the right of lease and utilization of energy infrastructure property for the purposes of distribution of electricity within the Closed distribution system of Luštica Bay;

Energy Regulatory Agency of Montenegro, by its Decision number 19/2203-7 of 1 August 2019, established the status of a closed electricity distribution system owned by the company Luštica Development AD Tivat, through which the electricity is distributed in the area of Luštica Bay resort in Tivat ("CDS"), appointing at the same time Luštica Bay ElectricityCompany doo Tivat for operator of a Closed Distribution System of Luštica Bay.

Luštica Development, as an investor in the construction of a residential building in which the Unit is located and

### **Obrázloženje**

Na osnovu Ugovora o dugoročnom zakupu i izgradnji od 23. oktobra 2009. godine, koji je zaključen između Vlade Crne Gore, Opštine i društva Luštica Development, društvu Luštica Development je, dodijeljeno ekskluzivno pravo da, bilo neposredno ili putem povezanog društva, distribuira i prodaje korisnicima komunalne usluge, kao što je električna energija u okviru projekta Luštica Bay.

Luštica Development je, za potrebe distribucije i prodaje komunalnih usluga korisnicima zatvorenog distributivnog sistema električne energije Luštica Bay, osnovala svoje povezano društvo Luštica Bay Electricitycompany doo Tivat („LBEC“);

Na osnovu Ugovora o zakupu energetske infrastrukture, od dana 28. Januara 2019. godine, koji je zaključen između društva LBEC i društva Luštica Development, društvu LBEC dodijeljeno je pravo zakupa i korišćenja enegretske infrastrukturne imovine za potrebe distribucije električne energije unutar Zatvorenog distributivnog sistema Luštica Bay;

Regulatorna agencija za energetiku Crne Gore, rješenjem broj 19/2203-7, od 01.08.2019. godine, utvrdila je status zatvorenog distributivnog sistema električne energije u vlasništvu društva Luštica Development AD Tivat, preko kojeg se distribuira električna energija na području Luštica Bay resorta u Tivtu ("ZDS"), imenujući istovremeno Luštica Bay Electricity Company doo Tivat za operatera Zatvorenog distributivnog sistema Luštica Bay.

Kompanija Luštica Development je, kao investitor u izgradnji stambene zgrade u kojoj se nalazi Jedinica i

the initial owner of the Unit, submitted to the LBEC a request on issuing the consent for connection to the Closed Distribution System Luštica Bay.

In accordance with the above and bearing in mind that the company LBEC is a sole and exclusive operator of the Closed Distribution System Luštica Bay, the company LBEC issues the consent for connection of the Unit to the Closed Distribution System Luštica Bay, provided that the Unit will be connected to the Closed Distribution System Luštica Bay when the conditions from the disposition of this Decision are completely fulfilled.
