Ovom Odlukom o utvrđivanju cijena i drugih naknada za priključenje i korišćenje Zatvorenog Distributivnog sistema Lustica Bay („Odluka“) utvrđuju se cijene i druge naknade za priključenje i korišćenje zatvorenog distributivnog sistema Lustica Bay preko kojeg se distribuira električna energija na području Lustica Bay resorta u Tivtu („Zatvoreni Distributivni Sistem“) i objavljaju cijene i naknade koje je Korisnik dužan da plaća Društvu u skladu sa članom 118 stav 7 Zakona o energetici, na sledeći način:

D E C I S I O N
on determining the prices and other fees for the connection and use of the Closed Distribution System Lustica Bay

This Decision on determining the prices and other fees for the connection and use of the Closed Distribution System Lustica Bay (hereinafter: "Decision") establishes the prices and other fees for the connection and use of the closed distribution system Lustica Bay through which electricity is distributed in the Lustica Bay resort in Tivat ("Closed Distribution System") and publishes the prices and fees, which the Consumer is obliged to pay to the Company in accordance with article 118 paragraph 7 of the Energy Law, as follows:

1. The Decision establishes the fees for the connection and use of the Closed Distribution System, which shall apply starting from **1 July 2024**, as follows:

In accordance with article 205 of the Energy Law, pieces and fees pursuant to paragraph 1 of this Decision shall be published on the official website of the Company.

This Decision shall enter into force on **14 June 2024.**

O b r a z l o ž e n j e

Lustica Development AD Tivat, u skladu sa odredbama Ugovora o dugoročnom zakupu i izgradnji od 23. oktobra 2009. godine, koji je zaključen između Vlade Crne Gore, Opštine i društva Lustica Development, je nosilac ekskluzivnog prava da, bilo neposredno ili putem povezanog društva, distribuira i prodaje korisnicima komunalne usluge, kao što je električna energija u okviru projekta Luštica Bay.

Lustica Development je za potrebe distribucije i prodaje električne energije korisnicima zatvorenog distributivnog sistema električne energije Lustica Bay, osnovala svoje povezano društvo Lustica Bay Electricity company doo Tivat.

R e a s o n i n g

Lustica Development AD Tivat in accordance with the provisions of the Lease and Development Agreement dated 23rd October 2009 executed between the Government of Montenegro, the Municipality of Tivat and Lustica Development, is the beneficiary of the exclusive right to, either directly or through an affiliate, distributes and sells utilities to customers, such as electricity as part of the Lustica Bay project;

Lustica Development, for the purpose of distribution and sale of electric power and distribution to the users of the closed electricity distribution system Lustica Bay, has established its affiliate Lustica Bay Electricity company doo Tivat;

Regulatorna agencija za energetiku Crne Gore, rješenjem broj 19/2203-7, od 01.08.2019. godine, utvrdila je status zatvorenog distributivnog sistema električne energije u vlasništvu društva Lustica Development AD Tivat, preko kojeg se distribuira električna energija na području Lustica Bay resorta u Tivtu imenujući istovremeno Društvo za operatera Zatvorenog distributivnog sistema Lustica Bay.

Zakonom o energetici, u članu 118 predviđeno da je operator zatvorenog distributivnog sistema jedini operator sistema i jedini subjekat koji utvrđuje cijenu i naplaćuje naknadu za korišćenje zatvorenog distributivnog sistema u skladu sa ugovorom opriključenju i korišćenju zatvorenog distributivnog sistema zaključenim sa korisnikom.

U skladu sa gore navedenim zakonskim ovlašćenjem, kompanija LBEC, kao jedini i isključivi operator Zatvorenog Distributivnog Sistema, je utvrdila cijene i druge naknade za priključenje i korišćenje Zatvorenog Distributivnog Sistema, u iznosima određenim u stavu 1, tačka dispozitiva ove Odluke.

Zakonom o energetici je, u članu 118 stav 7, predviđeno da je korisnik dužan da operatoru zatvorenog distributivnog sistema plaća korišćenje sistema na koji je zatvoreni distributivni sistem priključen, odnosno korišćenje prenosnog sistema i korišćenje distributivnog sistema u skladu sa naponskim nivoom, kao i druge naknade predviđene tim zakonom u skladu sa ugovorom o priključenju.

U skladu sa gore navedenim zakonskim ovlašćenjem, cijene i naknade, koje su uključene u ukupan iznos koji Korisnik plaća operatoru Zatvorenog Distributivnog Sistema, objavljene su u stavu 1 tačke 3, 4, 5 i 6 dispozitiva ove Odluke.

Montenegro Energy Regulatory Agency by its Decision No. 19/2203-7 dated 01.08.2019. established the status of a closed distribution system of electric energy owned by Lustica Development AD Tivat, through which electricity is distributed in the Lustica Bay resort in Tivat, appointing at the same time the Company, as the operator of the Lustica Bay Closed Distribution System.

Energy Law in the Article 118 provides that operator of a closed distribution system is the exclusive system operator and the only entity that determines the price and charges for the use of the closed distribution system in accordance with the agreement for the connection and use of the closed distribution system executed with the user.

In accordance with the above legal authorisation, LBEC, as the sole and exclusive operator of the Closed Distribution System has determinated the prices and other fees for the use of the Closed Distribution System, in the amounts as it is determined in paragraph 1 point 2 of the disposition of this Decision.

Energy Law in the Article 118 paragraph 7 provides that the user of the closed distributive system pays the use of the system on which the closed distribute system is connected, i.e. the usage of the trasmission system and usage of the distribution system in accordance with the voltage level, as well as other fees established by that law, in accordance with the agreement on the connection.

In accordance with the above legal authorisation, prices and fees, which are included in the amount which Consumer pays to the operator of the Closed Distributive System, have been published in paragraph 1 items 3, 4, 5 and 6 of the dispositive of this Decision.
